UK Land Policy Forum – Second Meeting: Tackling Corruption in Land Governance

Date: April 13, 2016 Time: 13:00-17:00

Place: Royal Institute of Chartered Surveyors (RICS), London

Summary

The 2nd UK Land Policy Forum meeting will discuss corruption in the land sector, provide updates on recent activities of Forum members, including DFID, and agree on the future direction of the forum.

Background

The first Forum meeting — held on 4 November 2015 at ODI — concluded that the purpose of the Forum is to provide a focus for debate, information and lesson sharing amongst UK stakeholders to inform DFID and wider UK policy and programming for strengthening of land governance and land rights protection.

Theme for second Forum meeting: corruption in the land sector and the PM's anticorruption summit

The land sector is one of the most fertile arenas for corruption, with one in five people, and as many as one in two in parts of Africa, reported to have paid bribes to access land services; only the police and the judiciary found to be more corrupt. Corruption is associated with unresponsive, unaccountable and ineffective land governance and is now under greater scrutiny as a result of rising commercial value of agricultural and peri-urban land in developing countries, and concerns that corruption may be facilitating large scale land acquisitions that do not conform to guidelines on responsible investment.

Building on the G8 summit discussions on transparency in 2013, the UK Prime Minister has proposed to hold an **anti-corruption summit in May 2016**; more widely, he has stressed the importance of secure property rights and greater transparency in business dealings as a foundation of open democratic societies. Yet there is scant evidence of how corruption in land acquisition occurs, and little systematic analysis of the relationship between drivers, actors and different types of corruption in land or of the implications for development policy and programming.

The next meeting of the UK land forum will share findings from recent work on land and corruption in developing countries by the LEGEND Core Land Support Team and others, and consider the policy implications for DFID and UK government.

Aim

The second meeting aims to discuss the current evidence on land and corruption and agree robust recommendations to share with the UK Government for the PM's Anti-Corruption Summit on 12 May.

In addition, the meeting aims to:

- 1. Share what is new and interesting on the agendas of Forum participants, including participation in the 2016 World Bank Conference on Land and Poverty;
- 2. Consolidate the discussions at the first meeting on the role and composition of the Forum; and
- 3. Define themes for discussion for the next two Forum meetings.
